3. Diocesan Tribunal

At the end of December 1977 there were nineteen priest Judges. There were ten Judges nine of whom were priests and one Sister. Two lay women serve as Notaries. There were seven Defenders of the Bond, all priests. One priest served as Promoter of Justice.

Number of cases decided each year: 1976 — 340 1974 - 1411975 - 2791977 - 432

There have been no contentious or criminal cases, nor cases concerning the nullity of Holy Orders in these years. There have been no canonical processes for examining heroic virtue.

A COMMON POLICY OF PASTORAL MARRIAGE PREPARATION FOR THE DIOCESE OF ROCHESTER

INTRODUCTION

The following Common Policy attempts to clarify the role of the parish priest or deacon, the Pre-Cana Conference and the social service agency in preparing engaged couples for the Sacrament of Matrimony.

The document is pastoral in its scope; that is, it deals with the relationship between the priest or deacon and the couple who have come to him to prepare for their marriage. The document is not meant to be a summary of the theology, canon law or liturgy of Matrimony. It is meant to establish procedures through which the parish priest or deacon may become aware of the couple's life style and beliefs and then share insights to assure their continued growth as a couple.

I. NEED FOR RENEWAL

There is today a greater awareness of the relational aspects of marriage as well as an increasing rate of dissolution. In the presence of these trends, true pastoral concern for our *people urges the adoption of a policy of marriage preparation for all couples which would facilitate their entrance into this sacrement. Accordingly, it is fitting that the couple be seen a number of times by the witnessing priest.
