"Millions of Catholics right now are unsure of what the Church does teach - and, as a result cannot firmly identify themselves as 'Catholic,' said Pulver, a regional director for Catholics United for the Faith.

He said many bishops, clergy and religious "have fallen under the spell of would-be theologians who place their own 'expertise' in dogma, morals and Scripture above the voice of Peter."

Another resolution deplored the "increasing instances where pastors are summarily removed from office, a development which creates grave concern among the Catholic laity.'

-- Urged the bishops to call A resolution adopted at the for defeat of the Equal Rights Amendment "as a matter of both prudence and protection of the rights of conscience.'

Opposed exception clauses in legislation that is intended to cut off Department of Health, Education and Welfare funds for taxsupported abortion.

- Asked Congress to bar any public or nongovernment agencies or advisory groups which support abortion, contraception sterilization. The resolution specifically named Planned Parenthood.

- Urged Catholics to withdraw their support of such public charitable agencies as the Community Chest and United Way if they support abortion and "contraceptive family planning." Catholics were asked to give their support to agencies which "do not offer the risk of the use of donations for immoral purposes."

Recommended the "widest possible participation" in the March for Life.

- Called for a "complete treatment" of both the Catholic Church's history and social doctrine in all church catechetical programs in order that Catholics can contend with the "false philosophies of








New York (RNS) -The Catholic Daughters of America has contributed more than \$6.5 million to a wide range of charitable and religious projects during the past five years, according to a financial report issued to members in connection with the CDA's mid-July 75th anniversary convention here.

Beneficiaries included patients in medical clinics in Latin America, Asia, Africa; flood victims in Honduras and Johnstown, Pa.; earthquake survivors in Guatemala and Italy, and battered wives who turned to the CDA sponsored House of Ruth in Washington, D.C.

The largest single CDA contribution was the funding of the \$750,000 Bicentennial Chair in American History at the Catholic University.

Sheen; Mrs. Phyllis Schlafly, national president of Stop ERA; Dr. Mildred Jefferson, national president of Right to Life; and Bishop Michael McAuliffe of Jefferson City, chairman of the U.S. Bishops Committee on Women in Society and Church.
