The process is under way to construct a profile of the man to replace Bishop Joseph L. Hogan who resigned as Rochester's seventh bishop Nov. 28 because of ill health.

A questionnaire prepared by the Selection of Bishops Committee has been mailed to all priests, sisters and brothers of the diocese as well as to all members of the three consultative bodies — Diocesan Pastoral Council, Priests Council and Sisters Council — and to a large sampling of the laity,

selected at random. A precentage of imprisoned, deaf, native American, black and Hispanic (using a questionnaire translated into Spanish) also will be sampled.

Those participating have been cautioned that the returns must be received by Dec. 15 or else they will be voided.

After the results are received, hearings will be scheduled involving each of the 10 diocesan regions. Anyone with an interest can attend such hearings.

Bishop Hogan, who was

named by Pope John Paul II as apostolic administrator of the diocese upon his resignation as its bishop, urged all participating to be mindful of the importance of the questionnaires.

"By identifying the needs of the diocese and the type of person best suited to meet them, those taking part in the survey will be rendering great service to the diocese and to the Church. I ask all filling out the questionnaires to give them their full, serious and prayerful consideration.

"I also want to remind

everyone that the questionnaires must be sent prior to Dec. 15 or they will not be tabulated.

"And for those not taking part directly I ask their prayers to the Holy Spirit so that they will be participating indirectly.

"I have even asked the Liturgy Office to come up with a special prayer campaign and have been assured that it will be ready for announcement in next week's Courier-Journal."

Father James Marvin,

chairman of the selection committee, stressed the importance of participants returning the questionnaires before the Dec. 15 deadline. The returns will be computerized at the diocesan Office of Planning and after the regional hearings, a report will be sent to the apostolic delegate in Washington. The results of the survey will be published in January in the Courier-Journal.

Since I will be Administrator after Nov. 28th, my activities will be accordingly limited. Although I feel considerably improved after my illness, my health is still such a serious factor that I am delegating Most Rev. Dennis W. Hickey to handle all the day-to-day administrative matters which will emerge until my successor assumes the office of the Ordinary of the Diocese of Rochester.

2. As Administrator I will officially recognize and work with the Pastoral Office Board of Directors with its present goals, directions and processes.

In view of the instructions of the Apostolic Delegate, the Priests' Council and the other consultative bodies will be continued for the sole purpose of participating in the Selection of Bishops process. The diocesan planning process will continue through the Ministerial Review Committee.

4. The Regional Coordinators (deans or vicars forane) will continue as the pastoral presence of the diocesan Church in their respective areas and will continue their usual administrative tasks. They also may be called on for assistance in the Selection of Bishops Process.
