### New York State Files Suit Against Scanner Operation

Elmira - New York State has filed a lawsuit against St. Joseph's Hospital and others, seeking to have the CAT Scanner on hospital property cease operation.

According to Douglas Eldridge, a deputy counsel of the Office of Health Systems Management (OHSM), the state attorney general's office filed a suit last month to get St. Joseph's to comply with an order made by the department last fall.

The scanner, which belongs to Standard Scanner Associates, is being operated by Scanner Diagnostic Services in the hospital-owned Medical Arts Building.

Named in the suit are Sister Martha Gersbach, St. Joseph's administrator; Daniel Donahoe, hospital board president; Warren Welch, president of Standard Scanner Associates; and Dr. Joseph Calderone, Elmira physician and presidents of Scanner-Diagnostic Services.

Eldridge, speaking from his Albany office, explained that the suit seeks to have the parties named "cease the operation of the CAT Scanner

; pending approval of their Health application" to operate the equipment, which, he added, he believes has not been filed.

The suit seeks to get a court order to enforce the order of the executive deputy director of Oct. 2, 1978, Eldridge said.

At issue is whether or not the private corporation operating the scanner needs state approval to do so.

Eldridge stated that this is the "only case in which we have issued an order to cease the use of a CT Scanner" that was not followed, and that is why the state chose to file suit.

Questioned further, he admitted that St. Joseph's is the only hospital to have been given such an order.

He added that "most people take our orders seriously."

A spokesman for the hospital said that the hospital had no comment on the suit. Dr. Calderone could not be reached for comment.

This is the third lawsuit concerning the scanner since the placement in the Elmira Medical Arts Building was announced. The first two were filed by the Finger Lakes

Systems Agency(FLHSA).

In August, the FLHSA Executive Committee sent a letter to the state Health Department asking the department what it's determination on the issue was. At one point, the FLHSA had filed suit against the state for not contesting the scanner's operation.

Those named in the suit have time to respond; Eldridge said that he did not know when court action may take place.
