Report on Respect Life Sunday

October 7,1979 marked the active participation of 124 parishes in the Diocesan Respect Life Sunday efforts. The sum of \$22,497.47 was contributed. One half of these funds will support the Human Life Office and their educational, legislative and pastoral programs for use by the parishes. The other half of the funds are being used to create and support a Pastoral Care Network throughout all the counties of the Diocese. Organizations in nine counties have received funds as of today. Livingston, Schuyler and Tompkins counties will receive funds in the near future.

Perhaps the most significant impact, however, was felt in the educational efforts at the parish level. Parishes took advantage of the many materials and suggestions provided by the Commission including:
