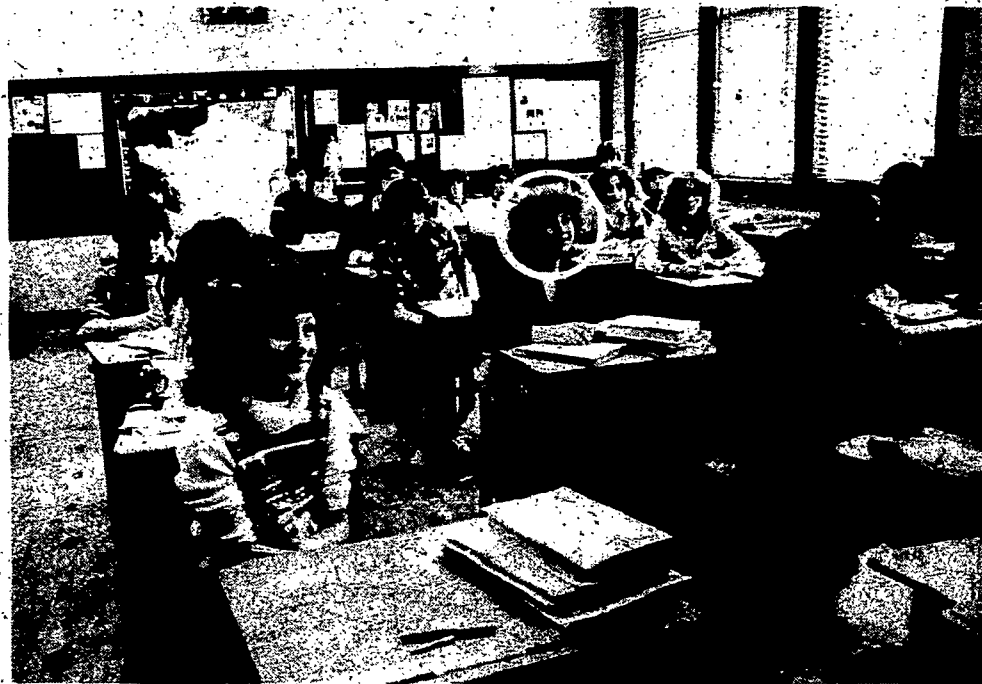
Ready for The Team

Time Out for Faith

Lent gives us an opportunity to reflect upon our relationship with Jesus. It is a transitional time of the year. We are well into the second semester, the winter sports season is ending and for many college acceptances have arrived. We look forward to spring sports, the spring musical, the senior ball and graduation. This time, then, is an invitation to slow down a bit in order to evaluate and enrich our lives in Jesus.

In any relationship there must be listening and there must be response. If we are to deepen our relationship with Jesus this Lent we must, first of all, learn to listen to Him as He speaks to us in so many ways, times and places. We must be willing to be alone in our room for a period of time each day. We must be

willing to be alone with Him in our parish church or school chapel. We must be willing at times to take a walk alone and let creation speak to us. We must be willing to listen patiently to a friend's problems showing the same patience as Jesus showed toward the Samaritan woman at the well. We must be open to God's Word in Sacred Scripture. We must desire to receive Jesus in the Eucharist. As we grow in an awareness of Jesus speaking to us we will find our own ways of creating an atmosphere for conversation with Jesus, that is, prayer.

If we really listen to Jesus this Lent, we will respond to Him. The response may be silence in His presence. It may be a prayer of gratitude for His love, of faith in Him, of petition for healing or of help in one's daily needs. It may be a reaching out to solve a friend's problem. It may be reflecting on a different Psalm or Gospel

passage each day. It may be daily sacrifice of some type for the needy of the world. It may be attendance at a youth Lenten service or participation in a youth Lenten retreat. Ultimately it may be the risk of committing one's life to Jesus. Whatever the response and however it is expressed it is a response and therefore, will most certainly result in a deepening of our relationship with Jesus.

In next Sunday's Gospel, (Luke 9:33), Peter exclaims, "Master, how good it is for us to be here." It is good for us to be experiencing this Lent 1980 so that we can accept the Church's invitation to listen to Jesus in our lives and to respond to Him in an ever more committed way. Let our prayer this Lent be, "O dear Lord, three things I pray — to see Thee more clearly, love Thee more dearly, follow Thee more nearly — day by day".
