## Bishop Clark Joins St. Anne's Jubilee

Bishop Matthew H. Clark was the principal concelebrant of the 50th Jubilee Mass for St. Anne's Church on Mt. Hope Avenue.

Concelebrating with him were the present pastor, Msgr. Charles V. Boyle; Father Robert Hammond, associate pastor; Msgr. William J. Naughton, former pastor; and several past associate pastors.

The festivities of the weekend were enhanced by the presence of Msgr. Naughton, now in retirement at St. Ann's/The Heritage. Msgr. Naughton served as pastor of St. Anne's for 22 years, during which time he oversaw the completion of the parish buildings, including the rectory/administration building and the present church.

A highlight of the Jubilee Mass was the introduction of Msgr. Naughton which brought the entire congregation to a standing ovation.

Following the Mass, Bishop Clark and several members of the jubilee committee walked to the neighboring Flower City Nursing Home where several founding parishioners are now residing. There, Bishop Clark visited the residents, blessed them and prayed with them. St. Anne's parishioners there also received flowers and copies of the anniversary booklet.

The day concluded with a reception at St. Anne's School.

Canandaigua — There will be a diocesan Mass for separated and divorced Catholics and their families Sunday, Oct. 19, at 2:30 p.m. at St. Mary's Church, Canandaigua, celebrated by Bishop Matthew H. Clark.

The Mass is sponsored by the Advisory Board of the Ministry to the Separated, Divorced and Remarried Catholics. During the 1980 Year of the Family, the Mass organizers encourage the separated and divorced persons to bring their children, extended family, or "whoever is family to them."

A reception with Bishop Clark will follow in the parish hall.

A planning committee comprised of support group members from around the diocese has prepared the event. Priests and sisters involved in the support groups will have a special part in the Mass, and some of the music will be provided by children of group members.

The Mass follows the celebration of the first diocesan Mass for the divorced and separated, also at St. Mary's, three years ago. Kathleen Kircher, director of the diocesan Ministry to the Separated, Divorced and Remarried, noted her hope that as happened at that Mass,

this celebration will be attended by many who feel alienated from the Church because of their marital status.

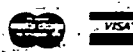
