Antisemitism In Decline From Mid 60s Survey Says

New York (RNS) — Antisemitism has waned since the mid-1960s — not due to people changing their minds, but because new generations lack the prejudices of their elders.

This is one conclusion of a new survey of attitudes towards Jews reporting that 34 percent of non-Jews held "prejudiced" views in 1981, compared with 45 percent of a survey sample questioned on the same issue in 1964.

The poll was conducted for the American Jewish Committee by the Yankelovich, Skelly and White research organization.

Daniel Yankelovich, the firm's chairman, stressed that there was no evidence that those who held antisemitic views in 1964 had significantly changed them since then.

The anti-Jewish feelings were most often found among survey respondents who were over 55 years old, less educated, black and living in large cities.

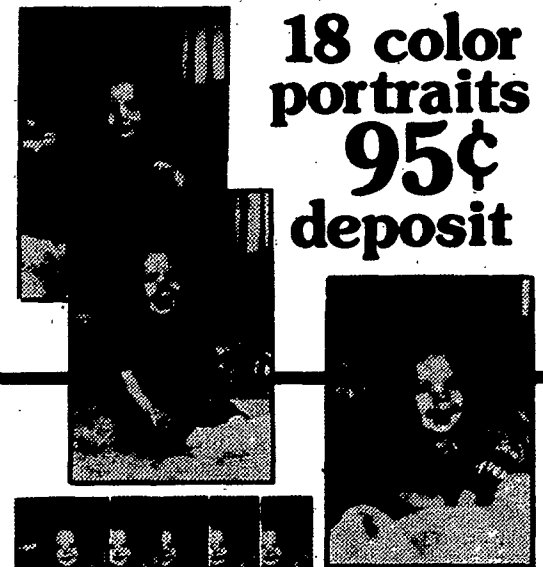
