

Charities Publishes New Report On Homeless Transients' Need

Diocesan Catholic Charities last week began circulating a report identifying a need for low-cost living arrangements for homeless and/or transient persons in Monroe County.

The report is the work of a number of persons and agencies, both civic and religious, convened by Charities "at the request of a small, informal group of social work, social ministry, and political persons who felt the impending close of the YMCA and YWCA dormitory residences would further the imbalance between the needs of homeless/transient persons and community-based

housing resources," the report stated.

The major findings of the group include:

"Single adults of limited means, who may have a need for inexpensive housing with some support services, but who are not eligible for mandated care (provided by the Department of Social Services, Mental Health, Youth Bureau, Office of Vocational Rehabilitation, and State Institutions for the Retarded and Developmentally Disabled), experience a small number of housing options.

"The supply of housing for this group is actually

declining, with long waiting lists at locations appropriate for many of these individuals.

"Many organizations are interested in this housing problem, but there is as yet no mechanism to focus energies and resources to find and implement solutions.

"Housing may be seen as a social living environment, not just shelter, and this observation has implications for whatever housing is arranged for the above individuals.

"There are no immediately identifiable financial resources for either capital expenditures or operations

costs for single adult housing with some support services."

"The housing problems of single transient adults of limited means are serious and require attention," the report states.

By October of this year, Charities will convene all the interested organizations and agencies with resources to focus on the problem. That meeting will develop a coordinated plan that establishes 150-200 rooms for single, transient persons.

The United Way will review the need for human services support to the single, transient person housing population and prepare a plan to meet those needs.

In addition, the initial group will again meet in October to review progress on resolving the problem.

The YWCA closed its residence on June 30 this year. The YMCA anticipates closing its residence before January 1983.
