

At that time, it was decided that the "questions raised should be dealt with in a concrete- fashion by the diocese, Father Schwartz said, hence the preparation of the diocesan policy statement.

By establishing a health board, the statement says, 'Any priest with a drinking problem may voluntarily seek help from this board. The bishop also has access to this board for assistance and advice in dealing with this disease. If a priest refuses to accept his disability as an illness in the face of competent recommendations to the contrary, the bishop may insist that he follow the health board's recommendation."

In addition, the priests encouraged the diocese to establish "an ongoing education and information program on alcoholism ... It is anticipated that this program will reach all levels of operation, including seminaries and houses of formation. The long range objective of this policy is "prevention."

The council statement said the primary purpose of such a diocesan policy "is to assist, intelligently and compassionately, those priests

who are disabled by the disease of alcoholism and/or other chemical dependencies. Our only intention is to help them regain that state of health and well-being which .will allow full productive and rewarding ministry in this diocese.


