## ACTION — HATCH AMENDMENT

The Human Life Commission asks your immediate action to move the HATCH-ASHBROOK Amendment through the United States Senate. Letters to your senators are vital to the passage of this important amendment, so please read and sign these letters and mail TODAY.

Dear Senator D'Amato:

Thank you for your past votes protecting unborn human lives. We must, however, be adament in our request that you place your name as co-sponsor of the Hatch Human Life Amendment. This is the piece of legislation we believe is most likely to be successful in

ending the present abortion on demand situation of our country.

When this legislation is debated on the Senate floor the end of April or the beginning of May, we request that you be present to protect the wording of the amendment as it is presently worded. We oppose any language changes which would weaken or add specific restrictions to abortion within the amendment.

We are aware of the many pieces of legislation presently available for your consideration and any legislation seeking to end abortion on demand should be affirmed. However, the Hatch Amendment is the legislation presently receiving the consideration of the Senate and it is the legislation which has the best chance of being successful at this

time in our country's history.

Again, your past record on this issue is appreciated but the time is now to end the factions and work in a united fashion for the sake of the unborn and the millions of women who are being exploited by the abortionist.

Dear Senator Moynihan: Every law established impacts upon the morality of our nation and laws by their nature serve as teachers of morality. Are we a nation whose morality says not to protect human life? To the contrary! We are always seeking to afford the protection of law to those who are minority group needing the protection of law in our society. Therefore, I am writing to ask you to lend your support and name to the Hatch Federalism Amendment.

As you know, this amendment has been passed out of the Senate Judiciary Committee and will be debated on the Senate floor the end of April or the bainning of May. In the past you have stated your personal opposition to abortion but have not been reflective of this stance by your voting record. As you like to say, we are a pluralistic society. However, we consistently oppose other areas where human life is taken such as through hunger, homelessness, applied and any large transfer areas where human life is taken such as through hunger, homelessness, capital punishment and nuclear proliferation. Human life is destroyed at the rate of 1.5 million unborn each year. Under the guise of pluralism we cannot condone the taking of even one life. We ask that you reconsider your position and vote according to your personal opposition and according to the majority of public opinion.

You have implied in the past that anti-abortion legislation is imposing one religious community's belief upon the nation. This is a flagrant avoidance of the fact that the Mormons, Lutherans-Missouri Synod, Greek Orthodox, National Baptist Convention, Orthodox Presbyterians, Jehovahs Witnesses, Catholics and Orthodox Jews oppose abortions. Add to these the National Association of Evangelicals, Ismal, Buddhist, Hindus as well as Christian Reformed Church Menonite, Southern Baptist and Southern Methodist Church. Lastly, no poll has ever shown a majority support for unrestricted abortion as we have now in the

United States. The Hatch amendment will return the decision on abortion to the elected representatives of the people. The Congress will at last have a chance to debate if abortion should be allowed for every reason or for just the hard cases of rape, incest and life of the mother or somewhere in between. For that reason we ask that even if you refuse to support the Hatch amendment, that you respect the voter's rights and not oppose its passage.
