Church **Teaching** On Morality

San Francisco, more than any other major city in the country, has tried to deal with the political reality of a highly visible homosexual population.

Evidently the Church authorities in the archdiocese felt a need to find some way of addressing this reality. Late last year, a task force connected to the archdiocesan Commission on Social Justice released a report which must have startled a lot of Catholic officials.

Its language struck me as intemperate. It rejected as ineffective the Church's traditional moral teaching on a number of sexual activities; it said that the traditional distinction between homosexual orientation and homosexual activity is "practically meaningless and pastorally

To my surprise, Archbishop John Quinn did not immediately object to the content and the public distribution of the report. Some time passed before the archdiocese issued a statement which recognized the existence of the pastoral needs and the fact of these opinions, while stating the obvious: a number of the judgments expressed in the report were in conflict with the authoritative teaching of the Church.

The argument goes on. A mid-February meeting of the Commission on Social Justice produced an angry exchange.

The chairman of the task force argued that the archdiocese was heavy-handed in short-circuiting "dialogue which has not yet even begun." He talked of "railroading" and announced that the entire handling of the process has credibility with me.'

Well, in my judgment, the archdiocese could not have retained credibility if it had handled the matter in any other way.

It is unrealistic for the Church to blind itself to the existence of homosexuality. It is also unrealistic to pretend that there is not a body of authoritative Catholic teaching on sexual morality. Whether one agrees with that teaching or not, it does exist.

Though it's difficult for a lot of Catholics to understand, there is also a difference between the formal teaching of the Church on issues of morality and the pastoral approach of a confessor or spiritual director.

Church teaching must express the faith and the judgment of the Church as it is perceived at this time. No matter how difficult and painful that teaching is for some people, those responsible for proclaiming the teaching of the Church must express that faith as it is understood today.

A pastoral response to an individual must respect that teaching, but it must also deal with the much more personal matter of this man or woman's relationship to

Nevertheless, pastoral sensitivity is not the same as authoritative teaching; it does not invalidate such teaching nor make it meaningless.

Authoritative teaching on moral issues does develop. The development usually takes into account new knowledge; it involves new distinctions, new explanations. It comes slowly and carefully, rarely with sudden reversals.

I assume that the members of this task force are motivated by compassion and an awareness of the urgent needs of men and women who are faced with painful problems of conscience.

These motives are admirable, but they do not change the fact that the Church has a teaching on sexual morality. Nor do they relieve Archbishop Quinn of his responsibility to proclaim that teaching.
