#### Nestle 'Committed' To Code -- Muskie

Cleveland (NC) -- The Nestle Infant Formula Audit Commission is independent of Nestle S.A., despite the fact it is funded by Nestle, said the commission's chairman, former Secretary of State Edmund Muskie.

Muskie, addressing UN-DA-USA, the National Catholic Association for Broadcasters and Allied Communicators, tried to dispel doubts that the company-initiated commission exists to "whitewash" Nestle's marketing practices. He spoke at the UNDA convention in Cleveland Nov. 11, four days before he was hospitalized in Maine with chest pains.

Muskie said independence was necessary to attract people to serve on the Nestle commission or its credibility would be questioned.

"In May 1982, I personally negotiated with Nestle a contract that the commission would be completely independent of Nestle," he Muskie said the 10-member commission includes three clergymen, two of whom are from denominations sponsoring boycotts of Nestle products and services. Several years ago, the third clergyman founded a task force challenging Nestle's marketing practices.

The commission investigates complaints that Nestle used marketing practices designed to tempt mothers of newborns to use Nestle formula rather than breastfeed their infants. Critics said Nestle did not follow the World Health Organization code for marketing, promoting and advertising the formula.

The WHO code attempts to prevent "promotion of infant formula products at the point of sale; use of employees dressed as nurses, promoting the products; introductory offers of reduced prices for formulas; and distribution of free samples."

Muskie said what is controversial is that mothers in developing countries buy the formula, dilute it because they cannot afford as much as their infants need and mix it with unsanitary water.

He said Nestle has issued instructions to its salespersons to follow the code, but noted enforcement is left to the governments of countries where the formula is sold.

"We believe Nestle is committed," Muskie said. "I have no reason to doubt that, in the year and a half of the commission's existence. The company has a willingness to adjust to the code. That's not to say they've done everything possible."

He said Nestle sells its formula in 100 countries. Nestle has sales of \$15 billion a year, but not more than 3 percent of that is from infant formula.

The Nestle budget for the formula commission in \$400,000. Muskie receives \$100 an hour to act as chairman of the commission.
