Writer Hopes Local Catholic Schools Won't Compromise on Church Doctrine

In the June 7 Democrat and Chronicle, there appeared a letter to the editor by William Sullivan, associate professor in the religious studies department of St. John Fisher College. Writing about homosexuality, Sullivan says that we "should rejoice in the diversity of God's creation, male and female, black, yellow, brown and white, gay and straight."

This statement leads one to wonder how topics such as homosexuality are treated in the religious studies department at St. John Fisher. Is Catholic moral teaching and biblical morality accurately and faithfully conveyed to the students?

Sullivan's letter reminded me of a recent article in Fidelity magazine in which the University of Notre Dame's "Counseline" was discussed. Taped messages on various questions can be heard by dialing a certain number on campus. Tape No. 20 contains this message on homosexuality: "Neither I nor anyone else can tell you what you should believe, but my own viewpoint is that religious and legal authorities have laid down rules against homosexual practices because of their own biases and fears and not because they have a more direct pipeline tothe truth than you or I." The tape then goes on to say that homosexual acts "can be very beautiful and positive." One student writing in the school newspaper noted: "a Catholic university cannot retain its integrity by denying the very values which make it distinctive. These tapes clearly do this."

Many Catholic institutions of learning, be they on the college level or the high school level, have compromised and diluted Catholic values and moral teaching to such a degree that they have become Catholic in name only. As an alumnus of St. John Fisher College, I hope that this hasn't happened at Fisher.

As a former theology student who 12 years ago lived a summer in Guatemala and two years in Bolivia and Chile, I have kept abreast of events in those areas. I am saddened to see yet another appropriation by our government of \$27 million of the cause of the contra military effort against the Nicaraguan people and government.

The contras are approximately 13,000 soldiers led by the officers left over from the repressive Somoza dictatorship which ruled Nicaragua for 35 years, collecting vast holdings for the few rich while keeping the masses impoverished. I feel the Reagan administration is morally wrong in supporting this military group which commonly employs terrorist attacks against civilians in this country that already went through a bloody civil war in the late 1970s, resulting in the ouster of the dictatorship.

I am saddened to see our government, which was founded on the principle of self-determination, once again intervening and in a sense already invading this small country as it has done elsewhere several times in past history. Granted, the Ortega government of Nicaragua has sought Soviet aid, but what seems more out of a selfpreservation defense. Would Jesus favor David or Goliath in this bitter conflict?
