it does not include all of Chemung County specifically excluding St. Mary Our Mother School, Horseheads.

Planning committee chairman Jim Snyder noted diocesan education officials were responsible for the exclusion of the Horseheads school. According to Snyder, diocesan officials said joint planning between Horseheads and Elmira should not be considered until both school systems have completed their initial five-year plans.

Snyder believes that a few parents will certainly pull their children out of the system. "But as time goes on and the level of emotionalism goes down, I think the reality will be that our numbers remain close to normal," he said.

Board president Jim Mirando said he had hoped for a unanimous vote as a sign of solidarity. "It seemed to come out that the buildings were the issue, but that our

strength is in our people - the parents, teachers and the children," he said.

"Now we have to do one heck of a marketing plan," Mirando added.

Marketing will be the province of the board's public relations committee, headed by Sister Patricia Carroll, junior high school principal.

Sister Patricia at present forsees marketing the system in three phases. Initially, she intends to concentrate on personal contacts with parents, explaining and answering questions about the reorganization and gathering their suggestions. A series of parent meetings are planned for that purpose during Catholic Schools Week in February.

To address parental concern over busing, Sister Patricia said that a parents' task force will be formed. The task force will also work with public school officials on such projects as designing bus routes.

Later in February and in March, the information gathered from the parent meetings will used to decide on and design specific marketing vehicles for the system - whether brochures or advertisements.

Phase three — registration — will continue from March into late spring.

Sister Patricia expects the marketing plan to focus on quality Catholic education as an alternative and to emphasize areas in which Catholic schools differ from public schools. Key areas for recruitment will be the pre-kindergarten and kindergarten programs and sixth graders entering seventh grade.

The last week in June has been designated as "transition week" for the schools. Also during that week, Sister Patricia hopes to use visits and tours to help acclimate children who will be moving to new buildings.

Parishioners at St. Patrick's, meanwhile, will have to decide the future of their school building. Father Daniel Holland, the pastor, plans to gather a parish task force to study possible uses for the building. At present, the only the basement is used by the social ministry committee. "There's no doubt that we don't need the whole building," Father Holland said, but noted he would like to expand the adult religious education program into at least part of it.

Several issues related to the five-year plan remain to be resolved by the Chemung County General Education Board. The names of the schools may be changed to better reflect the regional nature of the schools. Elmira-area pastors have suggested naming them after American saints. The board may also change its own name to include the word "Catholic."

Scheduled for discussion at the board's January meeting is the question of whether the system should offer kindergarten only as an all-day program, or whether a half-day option should be included.
