DPC elects executive committee; welcomes new members

The Diocesan Pastoral Council (DPC) last Saturday marked the end of its 12th year as a consultative body by adopting a new statement of its role and mission in the diocesan

A dozen years to the day after the council was formally established by Bishop Joseph L. Hogan on June 13, 1975, members voted unanimous approval of the following as its new mission statement:

"The Diocesan Pastoral Council is a consultative body which represents the people of God and is called together to participate in identifying needs, recommending priorities, and proposing actions for the Diocese of Rochester. This is accomplished by the members sharing their gifts and faith insights (and those of their regions and. ministries) in open dialogue with the bishop?"

Members of the DPC's executive committee - along with Cathy and Tom Frantz, representatives of diocesan renewal movements — developed the statement from reflections of fellow DPC members collected during the March 28 meeting.

The statement was introduced at a timely moment for seven new DPC representatives who attended their first meeting Saturday at St. Mary's School in Canandaigua. Also recognized were eight members who completed their three-year terms of service this year.

DPC members also elected seven representatives to serve on the executive committee during the coming year. Ronald Jodoin, a southeast region representative, was elected to a second term as chairman of the council. Carolyn E. Shulte of the northeast region was chosen vice-chairman. Other members elected to serve on next year's executive committee are: Brian McNulty, ecumenism representative; Garrett Mundelein, youth representative; Eileen S. O'Neill, Yates/Ontario/Wayne region; Jeanne M. Puceta, northwest region; and William Sponn, southwest region.

Bishop Matthew H. Clark presented the DPC with a summary of the Five-Year Financial Planning Process Task Force Report, which was issued last month. Compiled by a 20-member committee, the report called for a major fundraising campaign to support such long-term needs as ministerial training for lay people, a pension fund for religious and Catholic education. The report also called for further consolidation of Catholic schools and simplification of pastoral center administration.

During the bishop's forum segment of the meeting, Bishop Clark also reported on the work of the U.S. bishops' committee, which is drafting a pastoral letter on women in the Church. After spending the early part of last week in Pittsburgh with fellow committee members, the bishop said that he has been pleased by the committee's accomplishments to date, but also impatient at the pace of its

"I believe God's Holy Spirit is in this issue, and we'll be led in it, but we have a long way to go," he said.

grow over the months and some of the parents' attitudes change for the better.'

Greece resident Arnie Serotski had equally high praise for the sessions he attended with his wife and two 12-year-olds.

The design of the project was very good, in that it allowed kids to get a chance to

identify things they wanted to deal with in the sessions," he said. "Each session was relevant to the needs of the people in the group, as opposed to some pre-determined agenda set up by the counselors.

"It was designed to meet current needs to provide not just answers, but the selfesteem and communication skills to work through whatever problems this modern world presents kids with," he added.
"I was really upset," MacGregor said.

"I'm grateful that it was there for me. It's

just too bad it's not going to be available for us any more, or for anybody else. There's a real need out there."

Through the Catholic Family Center, Sinicropi will continue trying to meet that need by offering individual family life education workshops.

"We considered trying to continue the program independently," she said, "but the cost was way beyond what (any one agency) could absorb."

Meanwhile, if the district court's decision

is upheld, all 100 or more Family Life Demonstration Projects throughout the United States could be canceled.

Even if the ruling is eventually overturned, Girtman isn't optimistic about reviving the project locally.

'The staff has other jobs lined up, and the momentum with the families just isn't there any more," she said. "It would really be difficult to put the pieces back together again, and the longer it goes, the more difficult it gets.'
