Covenant House names priest as president

NEW YORK — Monsignor William J. Toohy, associate executive director of Catholic Charities for the Archdiocese of New York, has been named acting president of Covenant House.

Cardinal John J. O'Connor, who had been asked by the Covenant House board to assist in finding an interim chief executive who could restore public confidence in the agency, sent the name of Monsignor Toohy to the board on March 23.

The board, with some members present at the New York headquarters of the agency and others participating by telephone, approved the cardinal's choice the next day.

At the same time, board members also approved Cardinal O'Connor's recommendation that they name as deputy acting president Monsignor Timothy A. McDonnell, pastor of Holy Trinity Church and vicar for Manhattan's West Side.

Both appointments were to become effective March 27 and extend for not more than nine months. In accordance with a condition imposed by Cardinal O'Connor, they will be paid their regular salaries by the archdiocese.

Salary levels for some of the top executives of Covenant House, including the president's salary of \$98,000, have been among the topics of public controversy.

A search committee, headed by Covenant House board chairman Ralph A. Pfeiffer Jr., has already been named to seek a permanent successor to Franciscan

Father Bruce Ritter, the agency's founder who resigned as president Feb. 27 following allegations of sexual and financial misconduct. Father Ritter has denied the charges of improper behavior.

Under an agreement reached with Father Ritter at the time of his resignation, the permanent president must be a Catholic priest, nun or brother.

Following Father Ritter's resignation, the board accepted his recommendation that James J. Harnett, who had been serving under him as vice president and chief operating officer, be named interim chief executive.

Harnett replaced Frank J. Macchiarola, a professor at the Columbia University Business School and former New York City public schools chancellor, who had been acting president since Father Ritter went on leave Feb. 6, but who had upset the priest by moving quickly to make a number of personnel and administrative changes.

Macchiarola charged that he was ousted because he was trying to bring more light into controversial areas of the agency, and critics subsequently began demanding more far-reaching changes.

The board then appealed to Cardinal O'Connor for assistance in finding someone who could gain acceptance as an independent outsider.

However, since then three New York dailies — The New York Times, Newsday and The New York Post — have said editorially that restoring public confidence in Covenant House will require replacing the entire board of directors. The board has not responded to the editorials.

Harnett will now return to his former position as vice president.

Monsignor Toohy brings with him a degree from the Harvard Law School and various legal experience. He is also director of legal affairs for the archdiocese.

Although Manhattan District Attorney Robert M. Morgenthau announced the day

after Father Ritter's resignation that he was dropping the investigation he had launched into allegations of misuse of funds, New York State Attorney General Robert Abrams has continued and expanded an investigation.

Among the items under scrutiny in the Abrams investigation is a trust fund Father Ritter set up and used to provide loans to his sister and two friends on the board, as well as expense money for himself. But required reports to the Internal Revenue Service and the state attorney general apparently were not made, and Father Ritter did not inform the board as a whole about the fund's existence.

Couple commits \$15 million to aid Vatican

PHILADELPHIA (CNS) — A San Juan Capistrano, Calif., couple has committed \$15 million to help the Vatican's financial problems, according to Cardinal John J. Krol.

Cardinal Krol, former archbishop of Philadelphia and chairman of The Papal Foundation that has set a \$100 million goal as the first step in meeting Vatican needs, announced the gift made by Arthur and Gaye Birtcher.

Cardinal Krol said that so far the foundation had received \$31 million in gifts and pledges. The money goes into an endowment fund from which interest income each year will be allotted by the board for Vatican projects.

The Vatican faces a projected \$86 million deficit for 1990.

In announcing the Birtchers' contribution, which will be paid in installments, Cardinal Krol said "the success of The Papal Foundation will produce a lasting effect upon the life of the church until the end of time."
