


### **Letters Policy**

# **Planned Parenthood is deceptive**

To the editors:

I find it interesting that Planned Parenthood is upset with the recent Supreme Court ruling *Rust vs. Sullivan* that prevents Title X clinics from talking to women about the option of abortion. Planned Parenthood objects to withholding information that they say women are entitled to know.

I'm curious why Planned Parenthood has all of a sudden become concerned about information on abortion being withheld. Planned Parenthood has never talked to women about the *full* information about abortion. They have always withheld full disclosure to women about the complete factual reality of abortion, namely about the unborn child. They have never let women see through ultrasound and fiber optics what really happens to the unborn in abortion. They never inform women about the reality of fetal medicine that is able to do surgery to save the same life that abortion will take. In fact, in 1989 there were over 3,000 articles in the areas of fetal research, twice as many as the closest competitor - cancer research.

Because it withholds information about the unborn child within the woman, Planned Parenthood is one of the most deceptive organizations I know. Now it has the audacity to complain about withholding information from women. I would suggest Planned Parenthood do an experiment like one done by an abortion clinic in Washington, D.C. The clinic in Washington did a study with women coming in for abortions. Before the women went through with the actual abortion, they were shown pictures of their unborn child through ultrasound. After seeing their offspring through the marvelous technology of ultrasound, not one woman went through with the abortion she had planned on.

If Planned Parenthood wants *all* information about abortion to be given to women, then why don't they also show them brain waves, heart beat, and so many other human characteristics that the science of fetology has allowed us to see? If Planned Parenthood wants to be consistent and not hypocritical, then I would suggest allowing women to see, hear and interact with that life *before* the abortion. Let the women see on ultrasound, hear through the Dopler effect, and study through the marvelous technology of fiber optics the incredible world of their own child. Then let them have the information about what will happen to that life within them when a suction machine will tear that developing life to shreds.

In my experience of hearing a number of women talk about the devastating experience of abortion for them, they resented the fact that the information about the life within them was either trivialized or never presented fully to them so they could make a truly informed decision.

Yes, let's allow women to be *fully* informed to *all* aspects of what abortion really is — including seeing and hearing all about the unborn child within them — before they make a decision they can never take back and regret the rest of their lives.
