Article garbles Democrats' record


To the editors:

# Pro-life stance is healthier for the country

To the editors:

Recently newspaper columnist, Ellen Goodman, reprimanded Catholic Bishops; she wrote, the "bishops now consistently tell Catholic officeholders how to vote on one issue: abortion." Ms. Goodman's assumes that a religious stance against abortion should not be mixed with politics, and yet abortion is radically changing the demographics of our nation. Abortion and the abuse of contraception, rather than helping our country, are literally squeezing the economic and cultural life out of us. Planned Parenthood has been spreading a pro-abortion, pro-choice and procontraception philosophy which is causing aberrations in our population. For the first time in our history there are more people over 65 than under 5 years of age! In the decade ahead, to have children may become your greatest patriotic act for God and country.

Statistics prove that the present culture of the West — Europe and the U.S. — is being changed by the anti-life movement. Paul Marx, Ph.D., a noted population expert, has found that by the year 2035, the majority of people in France will not be French. The reproductive rate of the French is down to 1.2. On the other hand, for example, Muslim couples in France are having almost twice as many children. Since a country needs a rate of 2.2 to survive, the French culture is on the way out.

The Wirthlin Group found that in the U.S. at least 1.6 million babies are aborted annually — an entire generation since 1971! The U.S. now has a reproductive rate of less than 1.9, leaving our future more and more to depend on Department of Immigration for growth. I have to wonder who will pay into the social security system when my generation retires? If those of us in our 20s, 30s, and 40s do nothing to fight the anti-life movement, our culture and economic future will someday not exist as we now know it. When this group retires either the social benefits will be cut drastically for the elderly, or those children lucky enough to have been born will be taxed at exorbitant rates. Either alternative is undesirable. More than ever, from rich and poor families, we need children who will someday be wage earners.

Other countries, especially in Europe, which have abused birth control are seeing population surprises. 57 percent of all West German couples do not have a child; Germans are on the way out. In Switzerland, soldiers are needed so badly in the military that men must remain in active duty until age 53. In that country there are over a million foreigners working, 1/6 of the population. In England, because of the lack of social welfare dollars for the elderly, one is not allowed in the hospitals if one is over 65.

A Washington D.C. abortion clinic al-

lowed poor, pregnant women to see their fetus via ultrasound. After the viewing, each woman changed her mind and decided to keep her child. This fact proves that abortion, once fully understood, is not desirable. Flanned Parenthood has left women in the dark about fetal study and fetal development. Catholic bishops know all of this, that is why they are against abortion. It is anti-life. Any future pro-choice bill must include ultrasound prior to choosing abortion, so that women are better in-

When we teach that the dignity of childbirth is one of the fruits of sexual conduct, we show we have the will to love and to live. When we work to end abortion, we advocate for posterity and future security. When we replace our immediate selfinterest by what is economically good for our country and culture, we will take very seriously the long-term negative effects of the anti-life movement. The old biblical directive, "go forth and multiply," may still be the most reliable philosophy. Catholic Bishops are now armed with facts that prove that the pro-life stance is good for our nation. Is that not enough reason to ask officeholders to vote against funds for abortion.
