Ex-St. Ann's nurse charged for neglect

ROCHESTER – A registered nurse formerly employed by St. Ann's Home, 1500 Portland Ave., has been charged with unlawfully neglecting three residents at the facility and then falsifying medical records to cover up the conduct.

The alleged incidents were to have taken place last year. Edward J. Kuriansky, the state's special prosecutor for Medicaid Fraud Control, detailed the charges against Jacqueline L. Dennis in a March 16 statement.

The charges allege that Dennis intentionally failed to irrigate the catheter of a 83-year-old male resident in her care while working the overnight shift at St. Ann's March 17-18, 1993.

Allegedly, she also intentionally neglected two other patients, ages 85 and 86, by failing to clean and change their dressings for decubitus ulcers - or bedsores - as ordered by the patients' physicians. Dennis then allegedly concealed her conduct by falsely indicating in the patients' medical charts that she had actually performed the work.

According to Kuriansky, St. Ann's fired Dennis March 19, 1993. She had been employed there since September, 1988.

Kuriansky's statement noted that Dennis was charged with four counts of willful violation of health laws and three counts of falsifying business records in the second degree.

According to Jerry M. Solomon, special

assistant attorney general-in-charge of the special prosecutor's regional office, willful violation of health laws is an unclassified misdemeanor, while falsifying business records in the second degree is a Class A misdemeanor. Each act is punishable by up to one year in prison.

Dennis surrendered to authorities March 16 and was arraigned before City Court Judge Gary E. Smith. She has pleaded not guilty to the charges, according to her attorney, James E. Brown.

She was released on her own recognizance pending a pre-trial conference hearing, which will take place in the judge's chambers on Wednesday, March 23, Solomon said.
