United Way reaches goal for annual appeal

ROCHESTER – Despite concerns over the economy, a protest by a local pro-life group, and even recent articles that the campaign would fall \$500,000 short, United Way of Greater Rochester, Inc., has reached its goal of \$36 million in pledged contributions for this year's campaign.

According to Neal Haddad, United Way's director of communications, the organization received \$36,007,236 in pledges during its annual campaign from April 6 to May 19. Money raised through United Way is distributed to hundreds of area health-care and socialservice agencies.

During the campaign's final week, a number of local companies responded to the predicted shortfall by seeking out additional contributions before turning in their totals, Haddad observed.

'The community knew we needed a little bit more," Haddad explained. That spurred Eastman Kodak Company employees, for example, to contribute more than \$5.5 million in pledges - more than had been expected, he reported.

Haddad noted that the campaign had begun under a cloud created by concerns over the economy and ongoing cutbacks at large companies in the Rochester area.

"The campaign began with \$1 million in pledge card loss because of people no longer in the work place who gave last year," Haddad said.

As for a pro-life group calling for donors not to give to the United Way because of the organization's relationship with Planned Parenthood of Rochester and the Genesee Valley, Inc.,

11 Haddad said there was no discernible impact.

^{*}Destroying the campaign was not our goal," observed George Madden, a member of Citizen's for United way Responsibility.

Indeed, that was one of the points raised during a May 16 meeting of the pro-life group's core members – a day after local newspaper articles reported that the United Way campaign might fall well short of its goal.

"For myself, I've always been conflicted about harming United Way and doing anything that would deny funding to legitimate agencies," Madden said. "So naturally, I'm gratified that they made it. I would be distressed if they didn't make it – for the sake of the agencies.

"But I'm equally distressed that United Way - quite apart from the campaign - continues to directly associate itself with abortion and abortion-related services," Madden added.

For the past three years, Citizens for United Way Responsibility has asked that people donate directly to agencies they


wish to support - rather than the United Way campaign – to protest United Way's relationship with Planned Parenthood.

The group also asked that United Way move Planned Parenthood-from "member-agency status" to "donor-designation status." Such a move would ensure that contributions to United Way from people who oppose abortion would not go directly to Planned Parenthood.

Last December, United Way's board of directors approved a Planned Parenthood proposal that the agency receive only donor-designated funds.


As part of this agreement, however, Planned Parenthood remained a member agency. Thus it did not have to pay the administration fee that most donordesignation agencies must pay. In the case of Planned Parenthood, this fee, which was covered by United Way, amounted to tens of thousands of dollars, Madden estimated. Thus, members of the pro-life group argued that money from pro-life contributors to the United Way would still help Planned Parenthood.

Madden reported that the May 16 meeting saw members of Citizens for United Way Responsibility planning their strategy for the coming year. That strategy includes raising funds and developing an educational program focusing on Planned Parenthood and its relationship with the United Way.


