Mercy freshman falls in taught final

HENRIETTA - Based on past experience, Sue Ciccone knew there was no need to panic after losing her opening

Ciccone, an Our Lady of Mercy freshman, was pitted against Pittsford Sutherland junior Leila Monajati, who is also a good friend of Ciccone's and a fellow member at Tennis Club of Rochester.

"We always go back and forth," Ciccone said of their matches.

Yet Ciccone and Monajati met for much more than a friendly scrimmage last Thursday evening, Oct. 20, at Holiday Health Club. They were playing for the Section 5 championship, and Monajati had taken an early upper hand with a 6-2 first-set victory.

However, the players' evenly matched abilities were reflected in the second set when Ciccone rallied to win by the same 6-2 score. The players then battled closely through most of the third and final set before Monajati emerged with a 6-4 win in a match that lasted more than two and a half hours.

Despite the defeat, it was an admirable comeback for Ciccone, who dropped five of her first six games en route to the first-set loss.

Monajati, who had begun the match by cracking several blistering winners, appeared to tire slightly in the second set. Facing Ciccone's steady baseline game, Monajati's aggressive tactics only led to numerous unforced errors as Ciccone won that set's final four games.

After Ciccone took a 2-0 third-set lead, Monajati caught her second wind and the two players exchanged a number of lengthy rallies. Monajati, the tournament's No. 2 seed, won three straight games to go ahead 3-2 before the topseeded Ciccone took her final lead at 4-3. Monajati then captured the final three games to claim the set and match.


"You just had to hand it to Leila," remarked Mercy Coach Barb Hanna, who believed that Ciccone played superior tennis in the third set even though she could not withstand Monajati's impressive resurgence.

Ciccone said she was pleased with her level of performance after her slow start.

"I felt the best I've felt in awhile," she said. "I just didn't want to go out in two sets. In the first set I wasn't hitting quite as hard; I was a little tight."

One day after the sectional final, Ciccone nearly pulled off a big upset when she returned to Holiday Health Club for another intense battle - this time against Brighton's Anna Khvalina, who had not lost a set all year. Ciccone was eliminated in the Section 5 state-qualifier quarterfinal match, 4-6, 6-3, 6-3.

In Section 5 team competition held earlier last week, the Monarchs won 4-1 over Geneva in Class B quarterfinal play on Oct. 17 before falling 3-2 to Batavia in the Oct. 18 semifinals.
