

- 1. With the notable exception of Herb London for Comptroller, the Republican and Conservative Parties have betrayed their pro-life principles by nominating a pro-abortion statewide slate of candidates.
- 2. In 1992 Senator Al D'Amato won because of the vote on the Right to Life Party line. But this year, this same Senator wants only a proabortion Catholic candidate and selects George Pataki, who promptly switches his position to pro-abortion.
- 3. The Republican and Conservative leaders are hoping that the prolife voters' great dislike of Mario Cuomo will attract votes for proabortion George Pataki. As Ray Kerrison wrote in the *New York Post* on 5/27/94: "....it is too high a price to beat Cuomo on the shattered bodies of unborn babies....some things in life are nonnegotiable.

# WHERE TO THE CANDIDATES STAND ON ABORTION?

**Mario Cuomo** — "of course women should have the right to abortion, and we protect in this state that right even if they are poor. I support Roe v. Wade and we always have." (*Gubernatorial TV Debate 10/14/94.*)

**George Pataki** — "My position is very simple. I am pro-choice. It's the woman's decision. I support a woman's right to choose, regardless of what the U.S. Supreme Court does or what Congress does in Washington, we in New York should not take away the woman's basic right to choose." (*Empire State Report 8/94*)

".....I will continue Medicaid funding ......we are not going to deny Medicaid funding, and we are not going to put any legal impediments to abortion in this state...." (NY Times -10/10/94)

**Thomas Golisano** — "The United States of America and New York State have made it very clear on this issue; they want to be pro-choice so we are going to be pro-choice" (*Gubernatorial TV Debate 10/14/94*)
