Wayne County parish notes 150th year

Parishioners past and present will unite for the 150th-anniversary celebration of St. Anne's Parish, Palmyra, on the first weekend in August.

St. Anne's Parish was established in 1850 to serve a growing Irish Catholic community, many of whom settled along the Erie Canal after fleeing their homeland due to severe famine. Up until that point, the Palmyra area had been mostly populated by Protestants.

The current St. Anne's church building, located on Church Street, was opened in 1870. The church, which has undergone several renovations over the vears, survived a 1942 explosion and fire that closed the structure for eight months. Luckily, the new church hall had been completed just prior to the mishap, and Masses were held in the hall until the church was ready for reopening.

A parish school opened in 1961, but due to decreasing enrollment and rising expenses, it closed in 1972. Today the building serves as the St. Anne's Resource Center, providing outreach programs for the parish as well as the community at large.

In 1986, St. Anne's was one of the first parishes in the Rochester Diocese to become part of a cluster when it joined with St. Gregory's in Marion, located a few miles north of Palmyra. Father Louis Vasile, currently the pastor of St. Alphonsus Church in Auburn, served as the cluster's first pastor, from 1986-92. He was replaced by Father Robert Gaudio, the current pastor of what is now known as the Catholic Community of St. Anne and St. Gregory.

The sesquicentennial festivities will begin with a 6:30 p.m. dinner on Saturday evening, Aug. 5, at the Garlock House. The next day, Bishop Matthew H. Clark will preside at a 2 p.m. Mass at St. Anne's. The liturgy will be followed by a family-style picnic in Palmyra's Village Park, with those attending bringing their own lunches. Light refreshments will be sold.

Marj Taber, event publicity coordinator, said the parish would like to welcome back

former St. Anne's parishioners who may no longer live in Palmyra. Taber said that transportation is available for residents of adult-care facilities in Wayne and Monroe counties. She added that teens from the parish will be on hand to help visitors who have difficulty walking or are unable to walk. Those requiring transportation should call Vita Duffy at 315/597-9988.

Kathy Maxwell, a dinner co-organizer, said the jubilee celebration will also feature priests, women religious and deacons who have served the parish over the years, as well as teachers from the former St. Anne's School. Taber also noted that the jubilee Mass procession will include representatives from the parish's various committees and ministries.

Maxwell and Taber observed that many people with ties to St. Gregory's are helping prepare for the jubilee celebration of St. Anne's.

"We're probably one of the most successful clusters," Taber said. "We maintain our separate identities as far as buildings go, but we are very much a cluster as far as activities are concerned."

Ex-teacher faces charges in two towns

Alexander Capo, a former eighthgrade Spanish teacher at Our Lady of Mercy High School, Brighton, may wind up in Brighton and Irondequoit courts in August because he faces charges in both towns.

Capo was fired from his position at Mercy after being arrested in May for allegedly having an inappropriate relationship with a 13-year-old student. Incidents related to the relationship allegedly took place both in the school and in Irondequoit where Capo resided.

In Brighton, Capo faces one Class A

misdemeanor count of endangering the welfare of a child. In Irondequoit, he faces the same charge as well as an additional sexual abuse charge. Each charge is punishable by up to one year in jail.

Capo appeared in Brighton Town Court on July 17. Judge James E. Morris stated he would try to slate a jury trial for late August, but set no date.

Capo also will appear in Irondequoit Town Court on Aug. 2 for a conference with a Monroe County assistant district at-
