### **Obituaries** Mother Miriam O'Brien, OCD

Mother Miriam O'Brien, OCD, superior of the Carmelite Monastery in Pittsford, died Nov. 15, 2000, at St. Mary's Hospice in Rochester after a long illness. She was 88.

Born Mary Joseph O'Brien, the Carmelite nun was a native of Brighton, Mass, Upon entering the Order of Discalced Carmelites in 1936, she moved to Rochester and took up residence in the original Carmelite Monastery on East Avenue. The monastery is now located at 1931 Jefferson Road.

Mother O'Brien professed her final vows in 1940. As a cloistered nun, she was not permitted to leave the monastery grounds except for medical reasons or emergency.

Even so, Sister Magdalen Praetz, OCD, said that Mother O'Brien developed close relationships with people on the outside. She explained that Mother O'Brien was one of the few nuns in her Carmelite community who was designated to meet and talk with the public.

"She got to know people very well. These people began to love her for her compassion and help. She helped them through many trials, more so than others might. More and more, we have found how people have looked to her for advice," observed Sister Praetz, who has resided at the Carmelite Monastery since 1941

Although Mother O'Brien had been quite ill in recent years, Sister Praetz said, she was not given to complaining. "Her whole outlook on life was, 'God's will,'" Sister Praetz remarked.

Known as Mother Miriam of the Angels among her community, Mother O'Brien was finishing a three-year term as the Carmelite Monastery's prioress at the time of her death. Sister Praetz said that Mother O'Brien had also served previous terms as prioress during her lengthy stay at the monastery.

Mother O'Brien's funeral Mass was celebrated Nov. 18 in the monastery's chapel. Bishop Matthew H. Clark served as celebrant, and was joined by 15 priests. Interment was at the Carmelite Monastic Cemetery.

Mother O'Brien is survived by her sister, Nora A. Higgins; brother, Paul T. (Mary) O'Brien; nieces and nephews; and her sisters in the Carmelite Monastery. -Mike Latona

## SSJs issue sanctions to longtime member

Margory Henninger, a Sister of St. Joseph associated with the breakaway Spiritus Christi Church, remains a member of the Rochester order although she refuses to comply with orders from her superiors.

On Oct. 31, congregational leadership told her to cease calling herself "sister" in her work and in public, and to stop publicly identifying herself with the Sisters of St. Joseph.

Yet Henninger told the Catholic Courier that she has no intention of following these instructions.

Further, the congregation has stopped paying her stipend.

"It wasn't a dismissal at all," said Sister

#### Janice Morgan, who said she met with Sister Henninger Oct. 31 and gave her a letter at that time.

'We have been in ongoing discussion, because it has continued to be a struggle, and we continue to try to embrace her and keep her here as part of our family as a Sister of St. Joseph.'

In June 1999, the congregation's previous leadership began formal proceedings to remove Henninger. The new administration has chosen to go with sanctions rather than steps toward removal, however, according to Sister Morgan. The sanctions were necessary to demonstrate that the congregation was not lending silent approval to her association with Spiritus Christi, she said.

"If her family still calls her sister, if friends or relatives call her sister, that's fine," Sister Morgan said, adding the sanction related to Sister Henninger's work, "which all comes from Spiritus Christi, a church in schism.'

Spiritus Christi is, indeed, a church in schism, according to diocesan officials, who note that its members have excommunicated themselves from the Catholic Church. Its leader, Father James Callan, a diocesan priest and former priest administrator of Corpus Christi Parish, was suspended from active priestly ministry by Bishop Matthew H. Clark in December 1998

The congregation still covers health insurance and pension contributions for Henninger, who will turn 60 on Jan. 14.

Henninger is director of Grace of God House of Recovery, which she started a year ago in downtown Rochester as a Spiritus Christi outreach.

"We're not going further at this point," Sister Morgan said. "It's very hard. It's probably one of the hardest things we will do during this administration. It's wretching... We are praying that the reconciliation will somehow come."

'We have talked with her," Sister Morgan continued, "I don't want to use the word begged, and said we would open a recovery house and you can operate under the auspices of the Sisters of St. Joseph."

Henninger had served at Corpus Christi since 1977. She told the Courier that she refuses to sever ties with the Spiritus Christi people with whom she has associated for 20 years.

"I do not see this as an obedience issue," she said. She added that she cannot support the church's position on women's ordination, on homosexuality and on inter-
