Why do you keep on giving? Maybe... just maybe... because you see Jesus in his eyes!

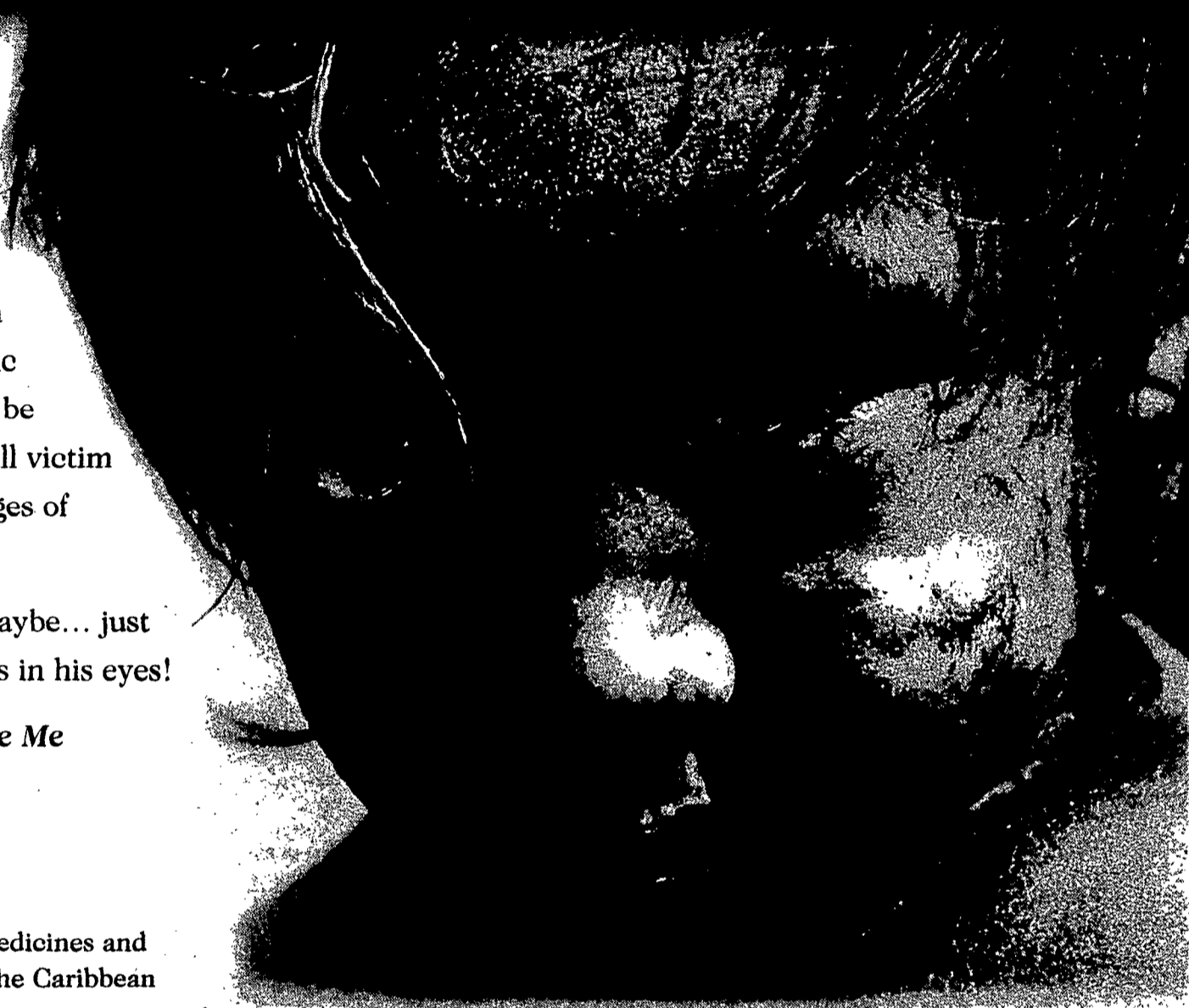
